- Any additional information you voluntarily share via SMS

We also collect data about your interactions with our SMS messages, including message content, date, and time.

#### 4. How We Use Your Information

We use the collected information to:

- Provide customer support
- Improve our SMS messaging service
- Comply with legal requirements

We do not use your personal information for marketing or advertising purposes beyond the scope of our SMS service.
